#### RESOLUTION NO. R - 02 - 14 - 16

A RESOLUTION SUPPORTING THE USE OF THE LOCAL GOVERNMENT INNOVATION TRUST FUND FOR PLANNING PURPOSES IN COORDINATION WITH SINCLAIR COMMUNITY COLLEGE AND COLLABORATING PARTIES

WHEREAS, Sinclair Community College (Dayton, OH) is making an application for Local Government Innovation Grant Funds to the State of Ohio Development Services Agency;

WHEREAS, said funds would be used to conduct a feasibility study to determine the need for and to plan a new training program for fire fighters, fire chiefs, and fire apparatus mechanics in southwest Ohio regarding the operation, maintenance and repair of emergency apparatus and equipment, to be delivered by Sinclair Community College, which would be available for all fire agencies in the region; and

WHEREAS, the anticipated, eventual outcome of the feasibility study will be a training program that will result in increases to a fire departments' equipment and apparatus reliability, decrease in equipment and apparatus down time, enhanced regional cooperation and interoperability for mutual aid agreements, and enhancement to fire fighter safety and prevention of injuries; and

WHEREAS, Sinclair Community College with the assistance of partners will be responsible for the completion of the feasibility study and planning process; and

WHEREAS, the City of Clayton, Ohio desires to work in collaboration with Sinclair Community College in support of the feasibility study.

# NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLAYTON, STATE OF OHIO:

- 1. That the City of Clayton, Ohio does hereby pledge its support for and collaboration with Sinclair Community College in obtaining Local Government Innovation Grant funds from the State of Ohio to determine the need for and plan a new training program for fire fighters, fire chiefs, and fire apparatus mechanics in southwest Ohio regarding the operation, maintenance, and repair of emergency apparatus and equipment.
- 2. That the City of Clayton, Ohio does hereby encourage the State of Ohio Development Services Agency to approve the grant application submitted by Sinclair Community College for the feasibility study.
- 3. That the Clerk of Council is hereby directed to send a certified copy of this Resolution to Rob Chambers, Chair of the Sinclair Community College Fire Science Technology Program, 444 West Third Street, Dayton, OH 45402.
- 4. This Resolution shall become effective immediately upon its passage.
